# RULES AND REGULATIONS FOR USE OF MECKAUER PARK

1. Park is open to the public.
2. All reservations of pavilion or other areas must be scheduled through the Parks and Recreation office. Applications will be accepted beginning Monday, March 21<sup>st</sup>, 2022.
3. The pavilion can be reserved by **Bethel residents only**. Application for use can be obtained at the Parks and Recreation office or online at: [bethel-ct.gov](http://bethel-ct.gov). On approval, copy of **Application** will be mailed to applicant and **should be in their possession when using the park**.
4. Areas that can be reserved; pavilion.
5. **2022 Rental Fee for use of pavilion: \$100.00 non-refundable fee required at the time the application is submitted.**
6. **No electrical hookups allowed.**
7. To prevent the hazard of broken glass in the park areas **no glass** is to be used in dispensing food or beverages.
8. **No alcoholic beverages** of any type shall be served or consumed on the premises.
9. **No smoking** on any town fields or parks. Smoke free zone.
10. **All litter and debris** should be placed in available dumpster or carried out.
11. All equipment should be put back in proper location (**picnic tables** etc.)
12. All fields and parks **close at dark**. All participants must leave promptly.
